## **Membership Agreement**

Beginning January 1, 2022, the following policies are in effect for all memberships:

- ❖ Membership dues may be paid monthly with automatic payment method.
- ❖ All membership dues are subject to tax.
- ❖ Membership dues are non-refundable.
- ❖ Monthly dues will continue until formal termination by either party. Members may resign at any time with written notice.
- ❖ Discontinued club memberships must wait 12 months to rejoin.
- ❖ Member accounts over 60 days past due will be suspended until account is paid in full.
- ❖ Medical disruptions that result in the inability to use club privileges will be handled by the Founders Group Membership Director. If approved, Club members may be eligible for a 75% reduction of monthly dues for a period of 2 to 6 months with proper medical documentation.
- ❖ Annual membership dues may increase at the discretion of the Club.
- ❖ Please contact your club's Head Golf Professional or First Assistant to add a payment method on your account.
